NOTIFICATION FOR ADMISSION INTO MBBS/BDS COURSES UNDER MANAGEMENT QUOTA IN TO AFFILIATED PRIVATE NON-MINORITY & MINORITY MEDICAL AND PRIVATE DENTAL COLLEGES AND NEELIMA INSTITUTE OF MEDICAL SCIENCES (AFFILIATED TO ANURAG UNIVERSITY)-2025-26

Application forms through online are invited from Indian Citizens, NRI's and Others (PIO, OCI card holders) who have qualified by securing the following cutoff scores or above in NEET-UG-2025 for admission into MBBS/BDS Courses for the academic year 2025-26 under Management Quota i.e. B- Category, C- Category (NRI Quota) into Private Un-aided Non-Minority/Minority Medical Colleges, Neelima Institute of Medical Sciences (affiliated to Anurag University) and Private Un-aided Dental Colleges, Army College of Dental Sciences affiliated to Kaloji Narayana Rao University of Health Sciences, Warangal in the State of Telangana.

Notification through online registration for web-based counseling to determine State Merit position for admission into Management Quota seats only. Provisional/Final Merit list will be displayed in the University website after scrutiny of all uploaded certificates. Total number of seats available under Management Quota for the academic year 2025-26 will be displayed on University website before counselling. Tuition fee payable was notified by the Government of Telangana as per G.O.Ms.No. 106 HM&FW (C1) Department, Dated: 28-07-2023 and G.O.Ms.No. 40 Higher Education (UE) Department, Dated: 20-06-2023.

Minimum Qualifying Score in NEET UG - 2025 examination for MBBS and BDS courses: Candidates should have secured the following cutoff score or above are only eligible to apply under Management Quota.

SC/ST/BC & PWD candidates of SC/ST/BC category	40th Percentile	113

NOTE: *LOWER PERCENTAGE / PERCENTILE OF MARKS FOR SC/ST/BC/OBC /PWD IS ONLY FOR CUT OFF SCORE FOR ELIGIBILITY.

Schedule for registration of online application and uploading of certificates:

Candidates can register online and upload scanned original certificates on website <https://tspvtmedadm.tsche.in> from **06.00 PM on 31.07.2025 up to 05.00 PM on 07.08.2025**

Provisional/Final Merit position of the applied candidates will be prepared based on NEET UG 2025 score and other eligibility criteria notified here under after verification of uploaded certificates. Final verification of original certificates will be verified by the Admission Committee at the time of admission at allotted college.

I. ELIGIBILITY:

- a) The candidates, who have qualified in NEET UG- 2025 by securing cutoff score and above, have to apply for determining the State Merit position for Management Quota seats subject to the conditions specified in admission Regulations/Prospectus. (Refer Regulations/Prospectus for detailed clarifications).
- b) 85% of the seats under Management Quota B Category for MBBS/BDS Courses in Medical & Dental colleges affiliated to KNRUHS are reserved for local candidates from Telangana state in accordance with GO.Ms.No. 130 HM&FW (C1) Department, Dated: 27.09.2022. The remaining 15% of the seats are open to candidates from all over the country including local candidates by merit.
- c) 25% of seats under Management Quota B category at Neelima Institute of Medical Sciences are reserved for local candidates from Telangana state.
- d) Candidates from all over the country are eligible for admission into Management quota seats Category C (NRI Quota) for UG Medical and Dental Courses.
- e) Foreign Students / NRI candidates are eligible for admission into MBBS and BDS Courses under Management Quota Category-C (NRI Quota) Seats. **Candidates should specifically put the option for NRI Category in the on-line application to be considered for Category-C (NRI Quota).**
- f) **There is separate registration for Competent Authority Quota and Management Quota. Candidates who have already applied for Competent Authority Quota Seats in response to this University earlier notification are also eligible to apply for the Management Quota seats.**
- g) The candidate should have passed Intermediate (10+2 pattern) or its equivalent examination with Physics, Chemistry, Biology (Botany, Zoology)/ Biotechnology and English

- i. OC candidates should obtain not less than 50% marks in science subjects.
 - ii. BC/SC/ST candidates should obtain not less than 40% marks in science subjects (for eligibility criteria only). **Reservations are not applicable in Management Quota.**
- h) The candidate should have completed 17 years of age as on 31-12-2025. **The candidates who do not complete 17 years as on 31-12-2025 are not eligible to apply.**
- i) The NEET-UG-2025 qualified and eligible candidates as per the regulations who desire to take admission into MBBS/BDS Courses shall apply online and upload all original certificates for determining the Merit position for Management Quota seats. The online application can be filled through any computer with internet connection.

(NOTE: PREFERABLY DESKTOP OR LAPTOP)

II. REGISTRATION AND PROCESSING FEE FOR MBBS/BDS COURSES:

Registrations from 06.00 PM on 31.07.2025 upto 05.00 PM on 07.08.2025	Registration and processing fee of Rs. 12,000/- (Bank transaction charges extra) shall be paid online through Debit Card/credit Card or Net Banking
Candidates who have registered for B category only and not registered for C category/NRI Quota and who wish to register for C category/NRI Quota after displaying of final merit list can submit application along with all relevant NRI documents with late fee before the issue of notification for web options for phase I, phase II and Mop Up phase	Late fee of Rs. 20,000/- in the form of demand draft drawn in favour of "THE REGISTRAR, KNRUHS" payable at Warangal.

**** Registration and processing fee once paid shall not be refunded nor adjusted to a further date.**

**** NEET-UG-2025 qualified candidates are advised to check their eligibility to apply for determining the Merit position in respective categories by following Prospectus/ Regulations carefully.**

IV. PROCEDURE FOR FILLING OF ONLINE APPLICATION, SCANNING/UPLOADING OF ORIGINAL CERTIFICATES AND ONLINE PAYMENT FOR REGISTRATION

- 1) The registration and processing fee can be paid through Debit card / Credit card or Net Banking.
- 2) **The registration and processing fee paid by the applicants is not refundable under any circumstances.**
- 3) Candidates claiming NRI quota should submit the following documents from a Blood relative such as Father/ Mother/ Brother/ Sister/ Uncle/ Aunt only and should submit a declaration to that effect.
 - a. NRI Sponsorship certificate (Declaration form) available in the prospectus at annexure – 1.
 - b. NRI status certificate of the financial supporter issued by embassy of respective country under their seal.
 - c. Copy of NRI Bank account pass book of the financial supporter.
 - d. Copy of Pass port of NRI financial supporter.
- 4) For OCI/PIO candidates, citizenship card shall be uploaded as proof.
- 5) Visit website through Computer with Internet connection to fill the application form
- 6) Fill all the details in the Online application form and upload all the documents which are mandatory and other relevant documents.

V.The candidate should submit the print-out of the filled-in online application form and original certificates along with one (1) set of self-attested copies to the Principal of allotted college at the time of joining for final verification. In case of any discrepancy, the provisional allotment order will be cancelled.

VI. MANAGEMENT QUOTA SEATS:

- A)** The MBBS/BDS seats available under Management Quota in all affiliated Colleges will be displayed on KNRUHS website before Counselling.
- B)** The MBBS seats available under Management Quota in Neelima Institute of Medical Sciences will be displayed on KNRUHS website before Counselling
- C)** BDS seats in Army College of Dental Sciences are reserved for wards of Army Personnel only.

IMPORTANT INFORMATION FOR CANDIDATES:

- i)** Candidates are hereby informed that if they have secured admission in Medical colleges of other states, joined the course and if they are involved in seat blocking under Management Quota in KNRUHS, the University will initiate legal action and also inform the same to National Medical Commission for further course of action.

- ii)** Online application form without uploading mandatory Certificates, Passport size photo, without signature at declaration area or incomplete applications will be automatically rejected and will not be considered for determining the Merit position in respective categories using NEET-UG-2025 Rank
- iii)** The mere fact that the Merit position issued to the candidate does not imply that the candidature is accepted by the University and it does not mean that the entries made by the candidate in the online application are accepted as true and correct
- iv)** Candidates eligibility for admission into UG courses for the academic year 2025-26 will be examined by the University only after scrutiny of application along with all uploaded certificates and provisional/final merit list will be displayed.
- v)** Registration along with uploading of scanned original certificates will be done only once irrespective of the number of counsellings. No separate notification will be issued for verification of original certificates. Therefore, candidates should register and upload all the mandatory certificates without fail.
- vi)** This notification is for online registration for determining the merit position using NEET- UG-2025 Rank only for eligible candidates under Management Quota. The schedule for exercising web options for admission to MBBS/BDS courses will be notified separately on University website. Candidates are advised to check the University website for notifications, counselling schedule, seat matrix and other details from time to time.
- vii)** An ineligible candidate obtaining Merit position does not make the candidate eligible for admission. Admission will be considered only for candidates, who have secured marks above cutoff score in NEET- UG-2025 exam and based on the merit order as the case may be.
- viii)** Scrutiny of uploaded original certificates shall be conducted by the University and concerned departmental officials. After scrutiny of application and certificates provisional/final merit list will be released. Candidates are advised to refer to KNRUHS website for further details regarding schedule for exercising web options. No individual communication will be sent
- ix)** Admissions will be in accordance with the Orders issued from time to time by State Government with regard to process of Admissions to Under Graduate Medical Courses for Management Quota and relevant Hon'ble Supreme Court and High Court orders.

- x) The procedure for preparation of seat matrix and selection into MBBS/BDS courses in the Management Quota and seat allocation will be done as the procedure given in G.O.Ms.No.115 & 116 HM&FW(C1) Dept, Dated: 05-07-2017, G.O.Ms.No.117 & 118 HM&FW(C1)Dept. Dated: 20-07-2017, subsequent amendments, G.O.Ms.No. 125, 126, 127, HM&FW (C1) , Department, Dated:22-09-2022, G.O.Ms.No. 130 HM&FW (C1) Department, Dated: 27.09.2022 and G.O.Ms. No. 33 HM&FW (C1) Department, Dated:17.08.2024 other Government orders, University Regulations and relevant Hon'ble Supreme Court and High Court orders.
- xi) Seats in Un-aided Minority Medical Colleges are reserved for Muslim Minority Candidates only. In case Muslim Minority Candidates are not available the seats may be filled up with Non-Minority students up to maximum of 30% during final Phase of counseling.
- xii) Candidates have to exercise web options for seats in the colleges in which they are interested to join for MBBS course and BDS course separately. Candidates and parents are informed to exercise web options very carefully in order of their preference for colleges and also to take a print out of exercised web options which are uploaded for reference.
- xiii) After allotment, the candidate should download the allotment order , submit the printout of the filled-in Online application form, allotment order, relevant bonds and original certificates along with (1) set of self-attested copies to the Principal of allotted college at the time of joining for final verification by the Admission Committee of the respective College. The Admission Committee is responsible for scrutiny of the original certificates submitted by the candidate. In case of any discrepancy, the provisional allotment order for admission will be cancelled.
